NO GAS CHAMBERS?

Advanced chemist Germar Rudolf says "no". Not only were most of the alleged 'chambers' incapable of containing the deadly cyanide gas, the walls of every 'chamber' show no incriminating iron-cyanide residue -- a telltale sign of heavy Zyklon-B (cyanide) use. To the contrary, every delousing chamber (for lice control of inmates) shows immense iron-cyanide residue due to Zyklon-B having been used for fumigation purposes. After several attempts to challenge these assertions by chemists such as Richard Green, Rudolf's conclusions remain irrefutable.

NO '6 MILLION' DEAD?

There is simply no sustaining evidence that total Jewish casualties within Nazi-occupied territories during WWII exceeded more than approximately 300,000 to 500,000. Not only is there no documentation to suggest any Jews were part of an 'extermination plan', but contemporary census data to account for the amount of missing Jews has been evidently scarce, inconsistent and unreliable. In some cases, post-war 'updated' figures have been released -- without any supporting data -- by Jewish institutions of questionable impartiality. A far more authentic approach has been contained within statistical analyses of census and demographic data, such as that conducted by Walter Sanning, which have been useful in establishing reasonable estimates despite a handful of noteworthy errors. While it is undoubtedly certain that many Jews perished unfairly in the turbulent conditions of wartime German-occupied territories, it has been relatively common for Jewish survivors to presume any lost relatives were 'exterminated' or 'gassed'. The reality is that countless Jews were separated from their families within the concentration camp system and emigrated to numerous locations around the world, following the war. Antisemitism was still present throughout Europe during this period, so many Jews changed their names, no longer affiliated as being Jewish, or other methods that would make it difficult for them to be located and identified. The International Tracing Service at Bad Arolsen, even today, reunites an average of 30-50 Jewish families per year. Based on a consideration of evidence, the figure of '6 million' is purely propaganda.

NO 'EXTERMINATION' SITES?

In addition to the [non-existent] tens of millions of pounds of human ash from alleged open-air cremations at various 'extermination' sites, there are claims of more than 2 million Jews having been murdered by the Einsatzgruppen, a specialized branch of the German military. Their bodies are said to have been buried in mass graves throughout Europe. Despite the exact location of several of these alleged graves being known, and despite modern technology which could easily verify the integrity and DNA identity of human remains, there has yet to be a single legitimate investigation to adequately demonstrate even one of the allegedly genocidal 'mass graves'. Photographs of the numerous WWII mass graves from throughout Europe are frequently mis-captioned and misrepresented by the Holocaust industry as Nazi atrocities against Jewish people. At least one mass grave, found in the Katyn forest, has been irrefutably proven to have been blamed on the Germans despite being a Soviet atrocity and cover-up.

HUMAN SOAP? SKIN LAMPSHADES? EVIL DOCTORS?

There are numerous testimonial claims of a wide variety of absurdities that have accompanied the widely-accepted 'gas chamber' tale. Among the most well-known are Ise Koch's alleged 'human artifacts'. However, others range from 'human spanking machines' to 'electric floor execution chambers', 'Nazi pot-shooting of newborn babies', and more.

NO QUESTION?

- The well-documented reality of Jewish internment in concentration camps during World War 2 begins, in part, with the Jewish boycott on German goods in 1933 and declarations of anti-German aggression from prominent Jewish figures in the Western world. Jews were perceived as a threat to the war effort in Germany and were thus imprisoned. This was similar to the Japanese internment within the United States.
- In every relevant German document, the "Final Solution" refers only to a policy of deportation for Jews to Eastern occupied territory at the end of the war.
- Despite a blatant lack of evidence for the official narrative, Holocaust Revisionists are labeled as though they are "denying" indisputable facts. "Holocaust Denial" is illegal in 13 European countries which means that researchers are frequently imprisoned for questioning the propagated storyline.

this crime. And yet much remains a mystery. Even some basic questions have no clear answers. For example, we would like to know:

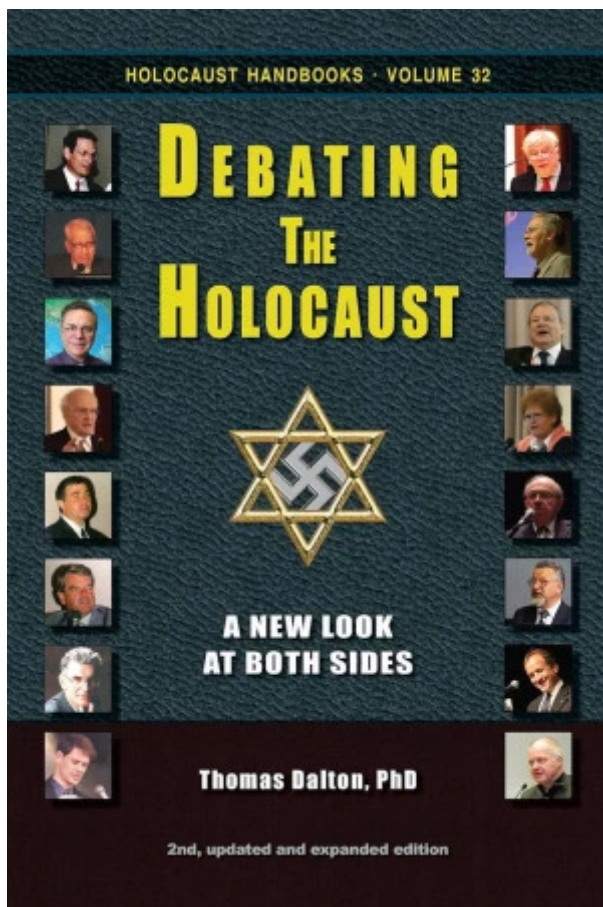
- Where did the six million figure come from?

DEBATING THE HOLOCAUST: A NEW LOOK AT BOTH SIDES



For the past few decades there has been raging a kind of subterranean debate, one of monumental importance. It is a debate about the Holocaust – not whether or not it “happened” (this is a meaningless claim), but rather, *how* it happened, through what *means*, and to what *extent*. On the one hand we have the traditional, orthodox view: the six million Jewish casualties, the gas chambers, the cremation ovens and mass graves. On the other hand there is a small, renegade band of writers and researchers who refuse to accept large parts of this story. These revisionists, as they call themselves, present counter-evidence and ask tough questions. Among the issues they raise are these:

1. There is no trace of a ‘Hitler order’ to exterminate the Jews;
2. key witnesses have either falsified or greatly exaggerated important aspects of their stories;
3. major death camps – Belzec, Chelmno, Sobibor, and Treblinka – have all but vanished;
4. we find little evidence of disturbed earth for mass graves;
5. we find few remains of the millions of alleged victims – neither bones nor ash;

6. mass-gassing with Zyklon-B would be nearly impossible without ventilators and ceiling holes;
7. mass-gassing with diesel engine exhaust is practically impossible, given the low level of carbon monoxide;
8. wartime air photos of Auschwitz show none of the alleged mass-burnings or cremations;
9. the '6 million' number has no basis in fact, and actually traces back decades before the war;
10. trends in Jewish world population strongly suggest less than 6 million lost; and
11. the present number of "survivors" – currently over 1 million – implies few wartime deaths.

The revisionists arrive at a different account. Hitler, they say, wanted to expel the Jews, not kill them. The ghettos and concentration camps served primarily for ethnic cleansing and forced labor, not mass murder. The Zyklon gas chambers did in fact exist, but were used for delousing and sanitary purposes. And most important, the Jewish death toll was much lower than commonly assumed – on the order of 500,000.

In this book, for the first time ever, the reader can now judge for himself. Arguments and counter-arguments for both sides are presented, and all relevant facts are laid out in a clear and concise manner. The entire debate is presented in a scholarly and non-polemical fashion. Citations are marked, and facts are checked. READ, and JUDGE FOR YOURSELF.

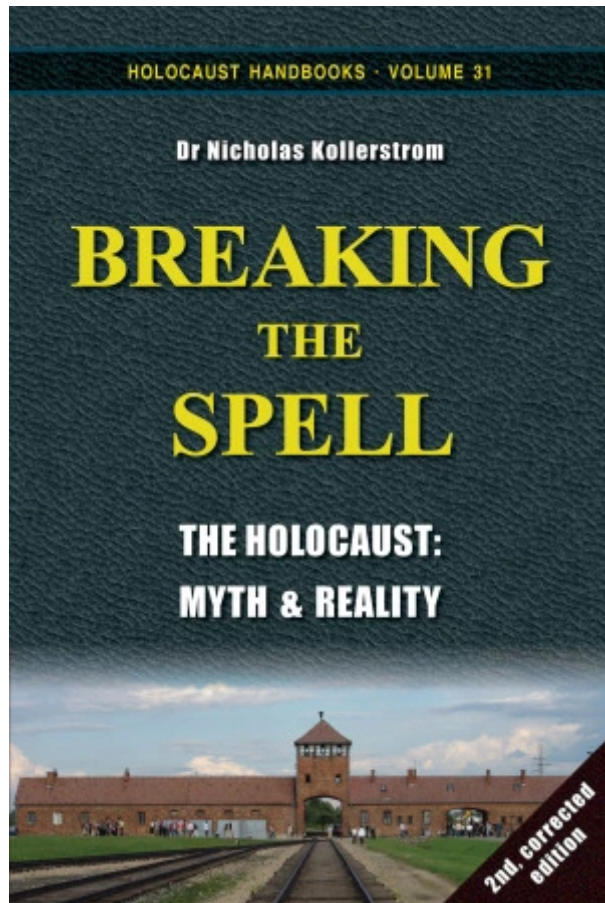

BREAKING THE SPELL: THE HOLOCAUST, MYTH & REALITY



In 1941, British Intelligence analysts cracked the German “Enigma” code. This undermined the German war effort – but also threw new light on day-by-day events in the Nazi concentration camp system. Between January 1942 and January 1943, encrypted radio communications between those camps and the Berlin headquarters were intercepted and decrypted. Oddly enough, historians have largely ignored the information furnished in these intercepts relating to “arrivals,” “departures,” recorded deaths and other events at these camps. The only reasonable explanation for this embarrassing omission is that the intercepted data seriously contradicts, even refutes, the orthodox “Holocaust” narrative. The revealed information does not expose a program of mass murder and racial genocide. Quite the opposite: it reveals that the Germans were determined, desperate even, to reduce the death rate in their work camps, which was caused by catastrophic typhus epidemics.

Were the British here hoodwinked by the Nazis, as some historians to this day try to claim—or is the truth both simpler and more shocking?

In 1988 and 1991 forensic studies threw light on the question of whether or not the claimed gas chambers at Auschwitz had served as slaughter houses for hundreds of thousands of people. Both studies had concluded that the only facilities where Zyklon B gas had been used were hygienic rather than homicidal, killing bugs rather than Jews. Needless to say that these iconoclastic studies were ignored or in some countries even outlawed, and that their authors were ostracized and even imprisoned.

Dr. Kollerstrom, a science historian, has taken these studies, which are in obvious, stark contrast to the widely accepted narrative, as a starting point for his own endeavour into the land of taboo. After he had published a brief paper summarizing what he thought the data forced him to conclude, he was thrown out of his College where he had been a member of staff for eleven years.

In his new book *Breaking the Spell*, Dr. Kollerstrom shows that “witness statements” supporting the human gas chamber narrative clearly clash with the available scientific data. He juxtaposes the commonly accepted ideas about a Nazi extermination policy toward the Jews with a wide array of mostly unchallenged, but usually unmentioned evidence pointing in a quite different direction:

- Zyklon B is a buzz word for the claimed Nazi mass murder, but all non-anecdotal evidence proves that this chemical was merely used as a pesticide in order to improve the inmates’ health and reduce, not increase, camp mortality.
- The Auschwitz camp authorities kept meticulous records of who died in the camp and why. A statistical analysis of the data does not match the kind of data to be expected, if the widespread view of what transpired in that camp were true.
- The UK’s intelligence decrypts prove that the German camp authorities were desperately trying to save their inmates’ lives.
- Zyklon B applied in delousing chambers formed chemical compounds detectable to this day. No such compounds can be found, but ought to be expected, in the claimed homicidal gas chambers.

- “Six Million Jews threatened or killed”: read 167 quotes from newspapers with that “news” spanning from 1900 to 1945, with a peak after World War ONE! Yes, one, not two!
- Germany has paid compensation to millions of Nazi victims, and Israel has implicitly admitted that many million Jews survived the Holocaust.
- A British archaeological team looked for traces of the claimed 800,000 victims of the Treblinka camp—and came back empty-handed.
- The Auschwitz camp had for the inmates: a swimming pool, soccer games, theatre, library, choirs, orchestras, hospital with modern surgeries...

Dr. Kollerstrom concludes that the history of the Nazi “Holocaust” has been written by the victors with ulterior motives and that this history is distorted, exaggerated and largely wrong. He asserts that this history is, in truth, a great lie that distorts our common perceived reality and misdirects human history to this very day.

THE FIRST HOLOCAUST: HOLOCAUST CLAIMS DURING AND AFTER WORLD WAR ONE



“The First Holocaust” by Don Heddesheimer is a critical work documenting the continuous Jewish attempts at floating out Holocaust propaganda before, during and after World War One, often invoking the magical “6,000,000” figure and using the term “Holocaust”.

Most people believe that roughly six million Jews were killed by National Socialist Germany during World War II in an event generally referred to as the Holocaust or the Shoah. But how long have we known about this six-million figure? The most frequent answer is that the six-million figure was established after the Second World War during the International Military Tribunal at Nuremberg.

already, while many more millions would face a lingering death. The *New York Times* was the main vehicle for such propaganda, which even included well-known buzzwords like “extermination,” “holocaust,” and the now famous “six million” figure.

Although this exaggerated propaganda of Jewish suffering slowed down during the 1930s, it never completely ceased and received new momentum in the 1940s during the Second World War. As we all know today, this propaganda skyrocketed after Germany’s total defeat, as the victorious nations of the Second World War seized upon the opportunity to take advantage of such propaganda and to increase its scope and impact. Heddesheimer’s book clearly shows that the origin of the “six million” figure, together with “extermination” and “holocaust” claims, are Jewish-Zionist in nature and part of a propaganda pattern that started at the very dawn of the 20th century in order to promote Jewish political and financial goals, be they in Soviet Russia then or in Israel today. Since the end of World War Two, this propaganda has increased in intensity due to its political success and the successful suppression of resistance against it.

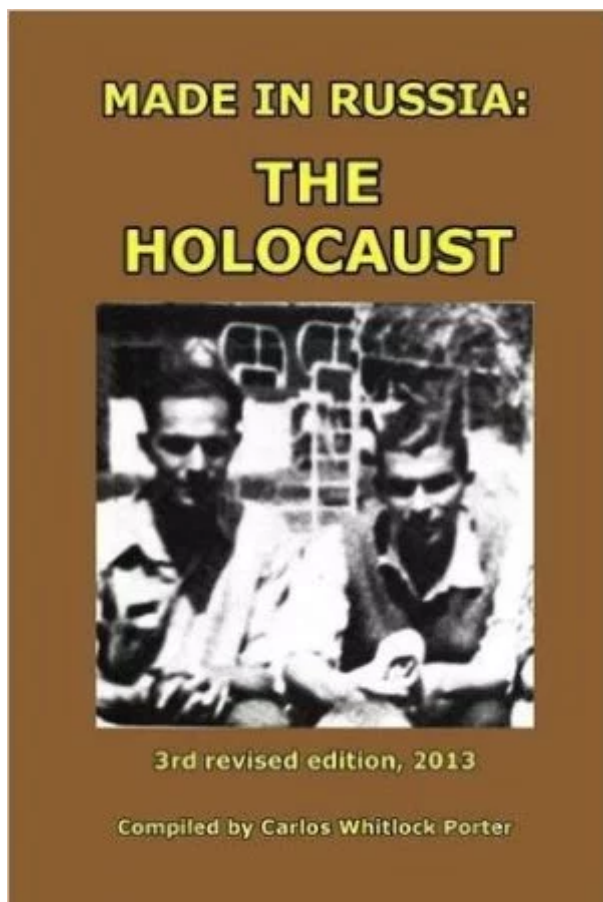

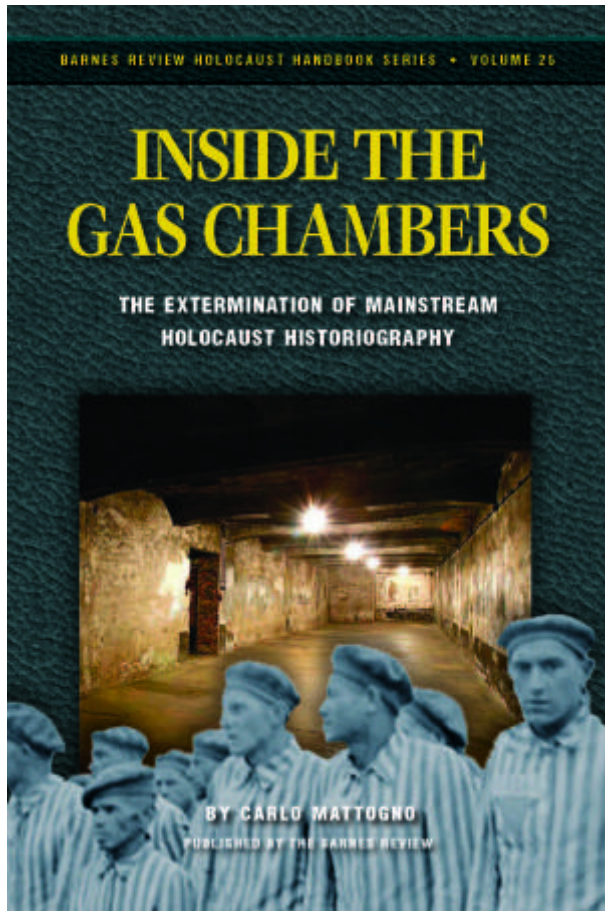
How many people know that at Nuremberg the Germans were accused of, along with killing about six million Jews:

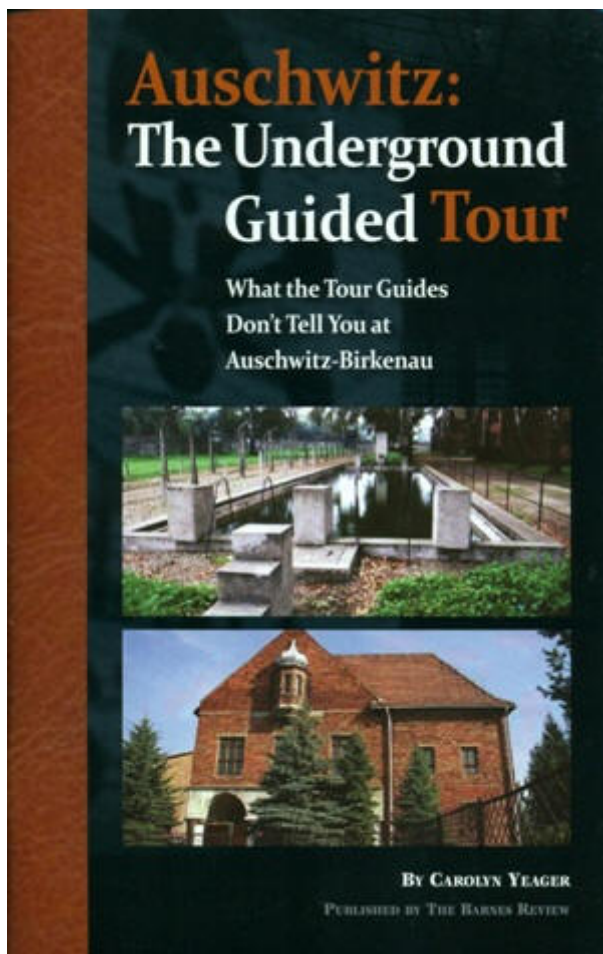
UDO WALENDY: FORGED WAR CRIMES MALIGN THE GERMAN NATION

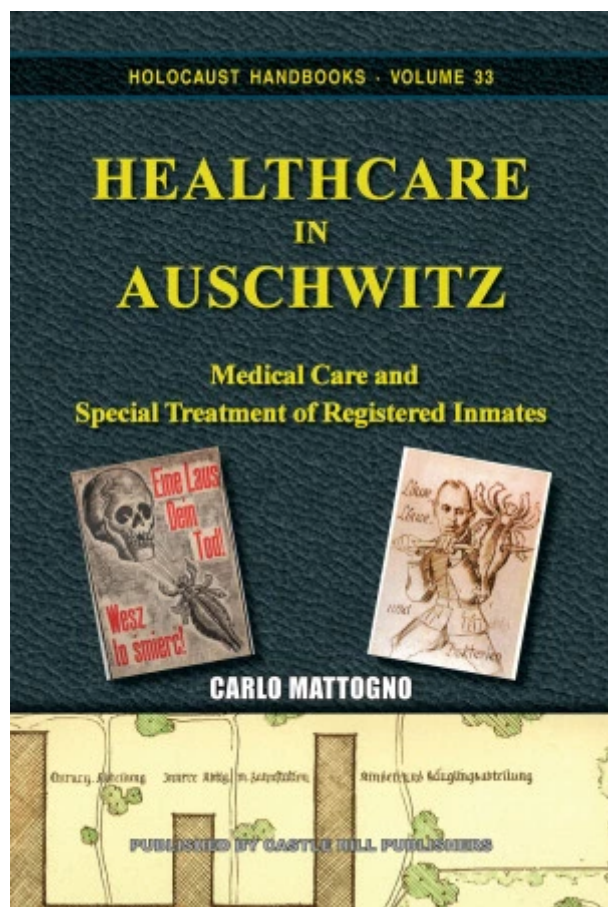

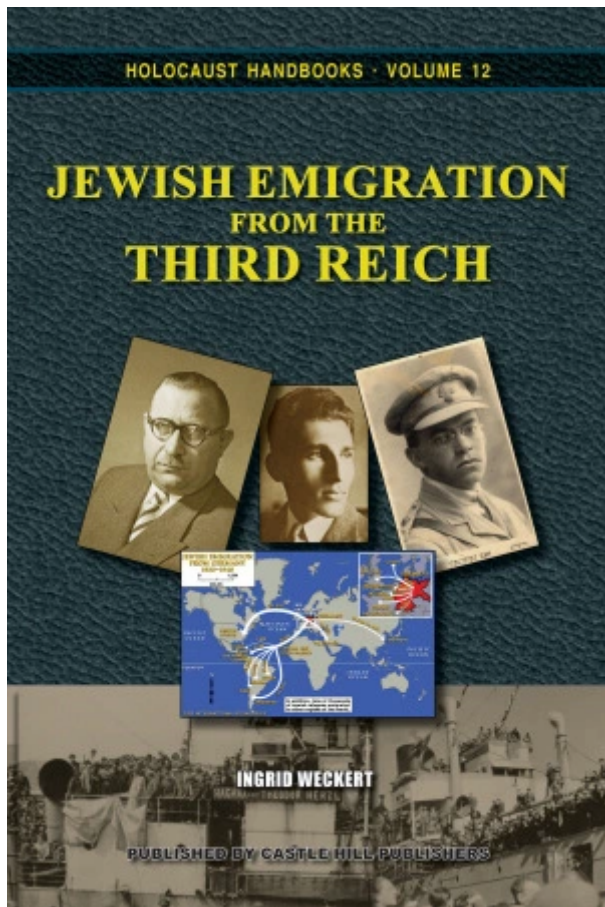

To this day there are still accounts of the Jewish emigration that depict it as some kind of clandestine operation – as if the Jews who wished to leave Germany had to sneak over the borders in defiance of the German authorities, and leave all their possessions and wealth behind.

The truth is that the emigration was welcomed by the German authorities, and benefitted from encouragement and assistance that increased over time. Emigration was not some kind of wild flight, but rather a lawfully conducted and regulated matter. Weckert's booklet elucidates the emigration process in law and policy, thereby correcting the traditionally received picture of Jewish emigration from Germany significantly.

German authorities and Jewish-Zionist agencies worked closely together on this emigration. Jews interested in emigrating received detailed advice and offers of help from both sides. The accounts of Jews fleeing Germany in secret by night across

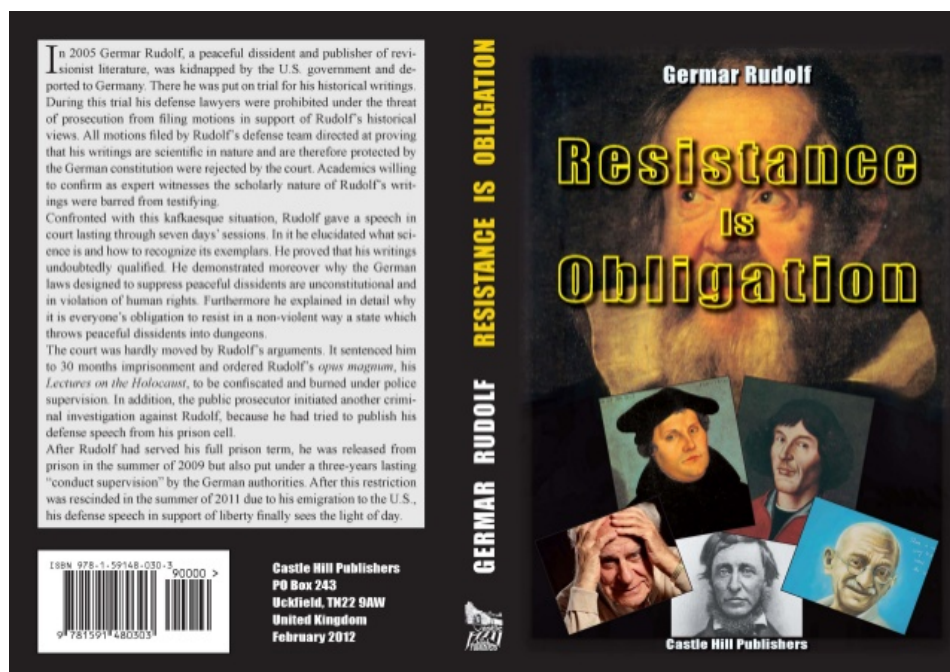

The uncensored inside story from the “thought criminal” himself—Germar Rudolf. Rudolf was a highly respected chemist with a promising career—a graduate of the Max Planck Institute—who made the “mistake” of telling the truth at a place (Germany) and time (during court) when lies are the only permissible public statements about the holocaust. When informed he would be sent to prison for his factual testimony made during a law case involving the holocaust, Rudolf went underground. He ended up in America, fell in love and was wed to his U.S. citizen sweetheart.

However, in late 2005, Rudolf—now a peace activist and publisher—was kidnapped by the U.S. government and deported to Germany to face charges of “holocaust denial.” There he was put on trial for his historical writings. During this trial his defense lawyers were prohibited under the threat of prosecution from filing motions in support of Rudolf’s historical views. All motions filed by Rudolf’s defense team directed at proving that his writings are scientific in nature and are therefore protected by the German constitution were rejected by the court. Academics willing to confirm as expert witnesses the scholarly nature of Rudolf’s writings were barred from testifying.

Confronted with this kafkaesque situation, yet undaunted, Rudolf gave a brilliant speech in court that lasted seven sessions. In it he elucidated what science is and how to recognize its exemplars. He proved that his writings undoubtedly qualified.

He demonstrated moreover why the German laws designed to suppress peaceful dissidents are unconstitutional and in violation of human rights. Furthermore he explained in detail why it is everyone's obligation to resist in a non-violent way a state which throws peaceful dissidents into dungeons.

The court was hardly moved by Rudolf's arguments. It sentenced him to 30 months imprisonment and ordered Rudolf's opus magnum, his Lectures on the Holocaust, to be confiscated and burned under police supervision. In addition, the public prosecutor initiated another criminal investigation against Rudolf, because he had tried to publish his defense speech from his prison cell.

After Rudolf had served his full prison term, he was released from prison in the summer of 2009 but also put under a three-years lasting "conduct supervision" by the German authorities. After this restriction was rescinded in the summer of 2011 due to his emigration to the U.S., his defense speech in support of liberty finally sees the light of day. The book also contains, among other things, a comprehensive documentation of the motions rejected by the court as well as two expert reports of historians who could not testify. Additionally, it is illustrated with a number of gorgeous drawings prepared by Rudolf during his time in prison, 16 of them in full color.

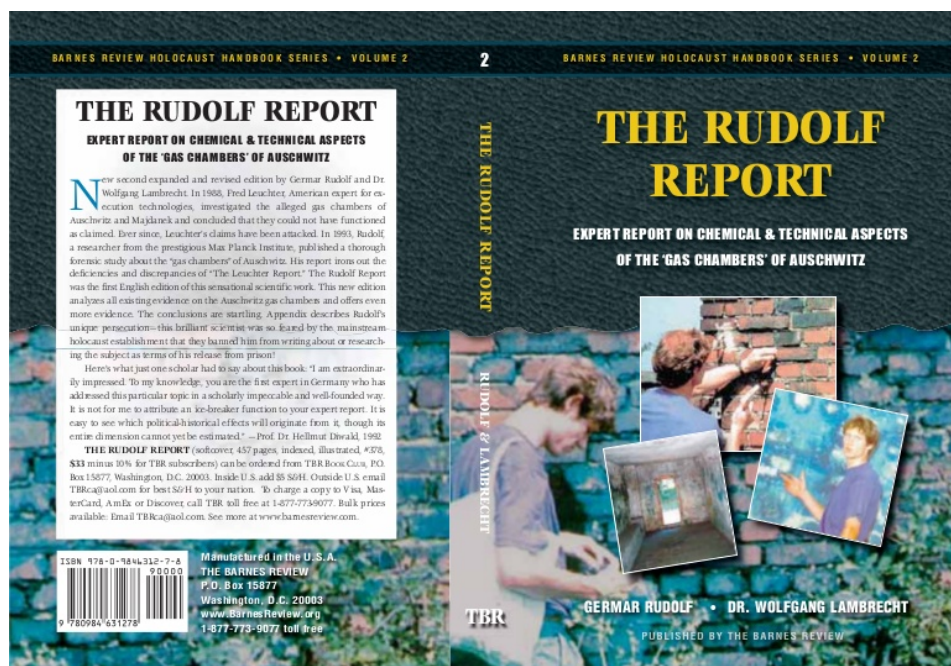

DIFFERENTIAL EXPOSURE OF BRICKWORK TO HYDROGEN CYANIDE DURING WORLD WAR TWO

Abstract

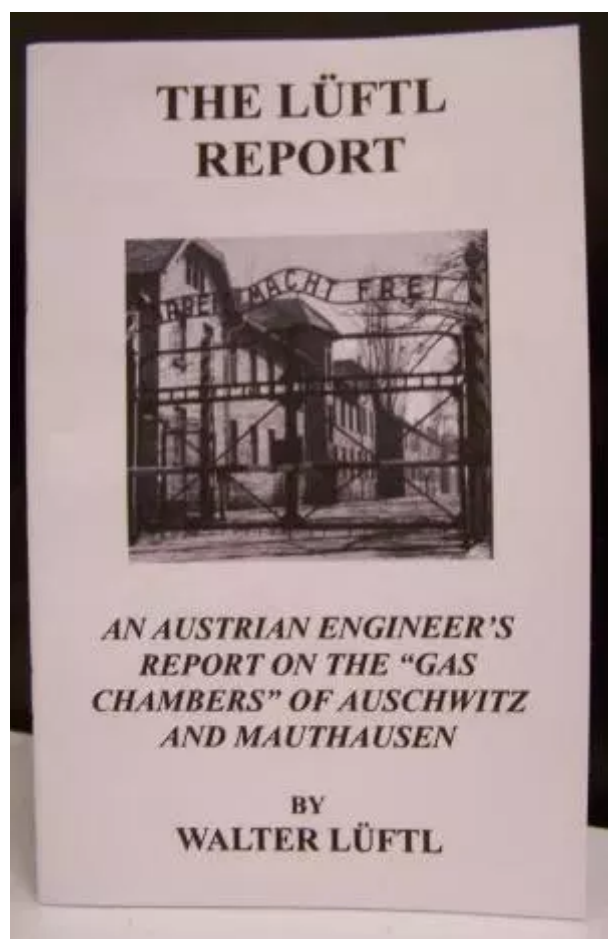
To this day, brick and mortar from the walls of the extant delousing chambers at the infamous Auschwitz–Birkenau concentration camp contain substantial amounts of Iron Blue residue, $\text{FeIII}_4[\text{FeII}(\text{CN})_6]_3$, also known as Berlin Blue or Prussian Blue. As this compound is insoluble to rain and resistant to wind and other natural forces, it

is not surprising its presence has persisted the past seven decades. It is usually, but not always, quite visible to the naked eye.

Various iron(III) oxide compounds are common in brickwork (bricks, mortar, cement, concrete, plaster), while cyanide compounds are not. The latter's presence in the brickwork of delousing chambers at Auschwitz-Birkenau is undoubtedly a function of exposure to gaseous hydrogen cyanide used during the camp's operation between late 1941 and early 1945. All analyses of exposed surface of other objects have to date revealed cyanide residues that are either very close to or below the detection limit. Difficulties with the existing analytical methods, which are not designed for these atypical host materials, need to be overcome to allow more definite conclusions.
